- 1) Bib Record Analysis Lindsay from La Crosse Public Library
 - a) Book on CD
 - i) 020/024- extra ISBNs not being deleted, or multiple versions (retail- Blackstone vs. library editions) purchased, possible cleanup of ISBNs? Libraries seem to have their own procedures when handling multiple entries
 - ii) 245 \$h recommendations for GMD or GMD use, too hard to standardize since often goes by discovery layer/system needs
 - iii) 264 4- not many used it for audiobooks compared to the print versions
 - iv) 306- most of us are using in audio records
 - v) 5xx- 500/538/588 fields as current recommendations go
 - vi) 655 7- Audiobooks genre term used by almost everyone, none for sound recording
 - vii) Subject terms- were pretty similar whether print or audio
