## Updates:

- 1) Bib Record Analysis – Lindsay S. from La Crosse Public Library
  - a) Youth fiction and Youth Nonfiction:
    - i) Youth Fiction-
      - (1) All chose different audiences-possible local practices
      - (2) Generally all fields aligned
      - (3) Age range- subfield \$b source being added, important?
      - (4) Only juvenile headings, or 650 x1, or both?
      - (5) Commonly used 650 and 655 Board Books also used with Toy Movable Books and Picture Books.
      - (6) Northern Waters uses macros to fill subfields in records.
    - ii) Youth Nonfiction-
      - (1) All disagreed as to fiction or nonfiction for Born on the Water.
      - (2) Disagreed with how title started for Born on the Water or if 246 At head of title entry needed.
      - (3) All generally matching for 300s, encourage use of 3xxs with RDA?
      - (4) Standardization of series information?
      - (5) Fewer instances of grades used more instances of neither grade nor age used.
      - (6) Used juvenile headings more than mix, used at least one 655 field.
- 2) Wiscat -follow-up with Joy P.:
  - a) Is there a test version to play with settings for bib retrieval?
    - i) Some customers have a test server and Auto-Graphics can create one for us to do mirror images of WISCAT. Joy P. will let us know when the setup is complete where it may take some time.
  - b) Would changing the order of first matches to ISBN first, then title, OCLC number, SkyRiver number, ISRN number, Publisher help in grouping results?
    - i) Numerics based on seed target standards so Auto-Graphics hesitates to change them but could setup in sandbox for manipulation if wanted.
      - (1) Question asked about reordering of matches and if it would make difference in results: Joy P. does not think that reordering would change results but it may be worth playing with to see if any difference.
- 3) Documenting recommendations:
  - a) Sub Workgroup met on 3/6/24.
  - b) Ideas to see what else exists for similar record guidelines to aid in creating our general guidelines for a record. Looked at other consortia's documents from other state systems.
  - c) Eventual website will include our recommendations with links that would connect to separate pages to make up keep easier with it as a living document rather than static and having to update the entire document every time there is a slight edit.

**New Business:**

- 4) Grant updates:
  - a) Jackee J. reached out to DPI with a proposal to continue current grant work in a third year grant. Waiting for information on possible federal funds and the ultimate breakdown amongst systems, etc.
  
- 5) Outline Work for Best Practices Document:
  - a) Create as complete of an 008 field as you can- audience, language code, format (Fiction, Nonfiction, Novels, Poetry)
  - b) Add 040 for language, not necessarily for local records
  - c) General guidelines- two tiers: required vs. enhanced
  
- 6) Local Subjects and Genres Document:
  - a) Need to have MOU for this grant cycle. The federal grant ends in June 2024. Jackee J. will reach out to Jen at MCFLS about doing project since possible interest was previously expressed.
    - i) Update: Jackee J. followed up with Jen S. at MCFLS and they will be unable to take this project on, so we will be working on it during upcoming meetings.
